Pursuant to Article IV 4 a) of the Constitution of Bosnia and Herzegovina, the Parliamentary Assembly of Bosnia and Herzegovina, at the 14th Session of the House of Representatives held on 6 September 2007, and at 9th Session of the House of Peoples, held on 29 October 2007, adopted

LAW ON AMENDMENTS TO THE LAW ON ADMINISTRATIVE DISPUTES OF BOSNIA AND HERZEGOVINA

Article 1

In the Law on Administrative Disputes of Bosnia and Herzegovina (“Official Gazette of BiH 19/02), in Article 4, the words "Commission for Real Property Claims of Displaced Persons and Refugees, established by the Agreement between Bosnia and Herzegovina, Federation of Bosnia and Herzegovina and the Republika Srpska on the Transfer of Powers and the Continuation of Financing and Work of the Commission for Real Property Claims of Displaced Persons and Refugees (“Official Gazette of BiH”, No. 32/04, 32/and 14/06), (hereinafter referred to as: Commission for Real Property Claims of Displaced Persons and Refugees)" shall be added after the words “public corporations”.

Article 2

In Article 8 paragraph (1) the words: "and the final act of the Commission for Real Property Claims of Displaced Persons and Refugees" shall be added after the words: “administrative act”.

Article 3

In Article 19 paragraph (2) the words: "two months", shall be replaced by the words: "60 days".

Article 4

In Article 21 paragraph (1) the word: "month" shall be replaced by the words: "30 days".

Article 5

In Article 39 paragraph (2) the words: "or decision" shall be added after the word: “judgment”.

Article 6

In Article 50 paragraph (3) the words: "five judges" shall be replaced by the words: "three judges".

Article 7

In Article 55 after the paragraph (1) new paragraphs (2) and (3) shall be added, which read:

"(2) Request for the protection of legality may be filed due to the violations of laws of Bosnia and Herzegovina, or due to the violations of the rules of procedure that preceded the rendering of the contested decision.

(3) Request for the protection of legality shall not be allowed against the decision rendered by the Appellate Administrative Chamber on the occasion of the request for reconsideration."

In paragraph (2), which becomes paragraph (4) the words: "five judges", shall be replaced by the words: "three judges".

The former paragraph (3) becomes paragraph (5).

Article 8

After Article 60 .a new part V-a shall be added and a new Article 60 a) which read:

"V-a OTHER PROVISIONS OF THE PROCEDURE

Article 60 a)

“Respective provisions of the law which regulate the law on civil procedure will be applied accordingly to questions of the procedure in administrative disputes that have not been regulated by this law.”

Article 9

In Article 7, 77 and 78 the word: “Central” shall be added before the word: “Election Commission”.

Article 10

In Article 79 the words: "as soon as possible and not later than within 10 (ten) days from the receipt of the appeal” shall be replaced by the words: "within three days from the receipt of the appeal”.

Article 11

In Article 80, paragraph (1), the words: "10 (ten) days from the day of the taking of the decision” shall be replaced by the: "two days from the receipt”.

Article 12

In Article 85 a new paragraph (4) shall be added after paragraph (3), which reads:

"(4) Exceptionally, lawsuits against final acts of the Commission for Real Property Claims of Displaced Persons and Refugees rendered after the signing of the Agreement from Article 1 of this Law shall be filed within 60 days from the day this Law enters into force."

Article 13

This law shall enter into force on the eighth day from the day of its publishing in the “Official Gazette of BiH”.
